ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**Prevention of Crime & Disorder**

1. The installation of CCTV internally and externally in liaison with and approved by the Lincolnshire Police to ensure effective surveillance of the premises.

Public Safety

1. Customer area kept free of obstructions and hazards.

Prevention of Public Nuisance

1. Marking/colour coding of containers to ensure premises responsibilities for waste and refuse collection around the town.
2. Where the premises provide food to the public for consumption on or off the premises there shall be provided at or near the exit a waste bin to enable disposal of waste food, food containers, wrappings etc.
3. Refuse shall not be permitted to accumulate on the premises to which the licence relates except stored in proper dustbins or receptacles with close-fitting lids in a manner approved by the Local Authority. The receptacles shall be maintained in a clean and wholesome condition, to the satisfaction of the Council.
4. A prominent, clear and legible notice shall be displayed at the exit(s) reminding patrons to leave the premises quietly.
5. The extract ventilation system shall be maintained so that it does not cause nuisance through either noise or odour emissions.

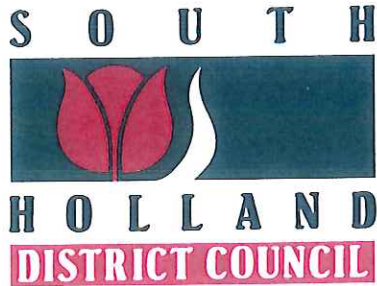
